4. First aid measures

Eve contact

6. Accidental release measures

Personal precautions

Methods for cleaning up

Small spill

Large spill

: Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Handling
